

JOAT University Membership Agreement

This Membership Agreement (“Agreement”) is made between **JOAT University, a division of PBJ Studios (operated by ProdByJo / Joseph Leslie Leon)** (“JOAT”) and the undersigned **Member** (“Member”). By subscribing or enrolling in JOAT University, Member agrees to the following terms:

1) Services Included

While actively subscribed, Member will have access to:

- **Educational Modules** (e.g., AI 101, Beat Making 101, Unreal Engine 101).
 - **Community Access** via JOAT Discord/Forum channels.
 - **Resource Library** (guides, templates, tools).
 - **Q&A & Feedback Opportunities** with JOAT mentors/admins.
 - **Exclusive Discounts** on PBJ Studios services (mixing, mastering, beats).

2) Membership Tiers & Billing

- **Free / Starter Tier:** Access to limited modules + community.
- **Grindset / Builder Tier:** Full access to all modules, resources, and community features, **plus one (1) monthly consultation call**.
- **Architect Tier:** Includes Grindset/Builder access **plus up to two (2) monthly consultation calls** (availability may vary), **early access to new content**, and **access to 24/7 support chat**.

Billing & Renewal

- Free Tier requires no payment but remains subject to this Agreement.
 - Paid tiers are billed monthly or annually depending on Member's choice at enrollment.
 - Subscriptions auto-renew until cancelled.
 - All fees are **non-refundable** once the billing period begins.

3) Ownership & Intellectual Property

- All course materials, guides, videos, and documents are owned by **JOAT University / PBJ Studios**.
 - Member is granted a **non-exclusive, non-transferable, revocable license** to use course materials **for personal educational purposes only**.
 - Member may not resell, redistribute, or publicly post JOAT materials without written consent.

4) Credits & Attribution

- If Member publishes projects or portfolios that **directly reuse JOAT-provided templates or resources**, Member must credit:
"Built with guidance from JOAT University by PBJStudios."

5) Limitations

- JOAT provides **educational guidance only**.
- JOAT makes no guarantees regarding commercial success, streams, placements, or financial outcomes.
- Member is solely responsible for results of applying JOAT materials.

6) Conduct & Community

- Member agrees to follow JOAT community rules.
- Harassment, hate speech, illegal sharing of materials, or fraudulent activity will result in termination without refund.

7) Termination

- Member may cancel anytime; access remains until the end of the paid billing cycle.
- JOAT may suspend or terminate membership for breach of this Agreement or community standards.
- Upon termination, Member must cease use of JOAT proprietary materials beyond personal study copies.

8) Warranties & Indemnification

- JOAT warrants course content is original and does not knowingly infringe third-party rights.
- Member warrants they will not misuse materials or violate third-party rights when applying JOAT knowledge.
- Member agrees to indemnify JOAT/PBJ Studios from claims arising from their misuse.

9) Miscellaneous

- Independent relationship: membership does not create employment, partnership, or agency.

- This Agreement shall be binding upon successors and assigns.
 - Entire Agreement; amendments must be in writing.
 - Severability; waiver not continuing.

10) Confidentiality

Both parties agree not to disclose the financial or contractual terms of this Agreement, or distribute JOAT proprietary materials beyond authorized personal use, except as required by law.

11) Dispute Resolution

In the event of a dispute arising out of or relating to this Agreement, the parties agree to first attempt resolution through good-faith mediation. If mediation does not resolve the dispute, the matter shall be submitted to binding arbitration in the State of Georgia under the rules of the American Arbitration Association. All costs of mediation and arbitration shall be borne by the Member. Judgment on the arbitration award may be entered in any court of competent jurisdiction.

12) Governing Law

This Agreement is governed by the laws of the State of Georgia, United States.
